(January 15, 2014) -- In compliance with Internal Revenue Code Section 6045B requirements, Regency Centers Corporation announces today that the 2013 calculation of earning and profits to determine the portion of the 2013 dividend payments that represent a return of capital has not been completed. We may have a small portion of the dividend that will be a return of capital, but the amounts have not been finalized. When the calculation of earning and profits is completed, Regency Centers Corporation will post Form 8937, Report of Organization Actions Affecting Basis of Securities, on our website.
